<p><u>5. District Councillor's Report</u></p> <p>a. District Councillor Edwards-Winser reported that Sevenoaks District Council has requested a response to the Community Plan Consultation.</p> <p>b. The Legislation & Supplementary Planning Document prepared by Mr Shelton has been forwarded to SDC for approval.</p> <p>c. New revisions have been made to the policy for Traveller Sites. SDC is obliged to review all applications in this category that have not be determined and to apply the new policy.</p> <p>d. A meeting has been held with SDC, KCC and the Scouts regarding the new fence surrounding the Scout Hut. It has been established that the new fence will be the subject of planning permission and a retrospective application will be made to SDC by the Scouts. KCC Rights of Way has advised that the fence has been erected within the boundary of the ancient highway and will have to be moved.</p> <p>e. District Councillor Edwards-Winser has attended a meeting on the prospective east facing slip on the M26. It has been suggested that a slip is positioned between Borough Green and Westerham. A consultation will be carried out on the economic benefits to installing a slip at various positions along the M26.</p>
