Comments by 13 August 2015.	<p>Oxford Parish Council objects to the proposed development for the following reasons:</p> <ol style="list-style-type: none"> 1. Oxford Parish Council has concerns about the proportional height of the roof. 2. The proximity of the property to the boundary is less than 1 meter. 3. OPC recommends the ridge height of the garage is reduced or hipped which would be more in keeping with the street scene. 4. The NEW side window is beyond the rear of the neighbouring property and OPC would recommend suitable screening bearing in mind the proximity to the boundary. 	
SE/15/02131/ HOUSE	7 Hale Lane, Oxford	The erection of a side garage extension for car and storage. Comments by 17 August 2015.	<p>Oxford Parish Council objects to the proposed development.</p> <p>The size, bulk and position would have an overbearing impact in this prominent location and would therefore reduce the openness of this prominent junction. The proposed development is not consistent with the building line and therefore out of keeping with the character of the street scene resulting in an incongruous form of development. This is not in accordance with policy EN1 of the Sevenoaks District Local Plan and SP1 of the Sevenoaks Core Strategy.</p>
