Action

1. Appointment of Chairman

Cllr M Evans was appointed as Chairman.

2. Appointment of Vice-Chairman

Cllr N Fothergill was appointed as Vice-Chairman.

4. Apologies

Apologies were received from Mr R Beasley (Parish Agent) and Mr B Thomas.

- 5. <u>Declarations of Interest</u> None.
- 6. Minutes

The Minutes of the previous meeting of the Recreation Ground Committee held on 30 March 2015 were agreed as an accurate record of the meeting. The Minutes of the previous meeting of the Environment Committee held on 3 March 2015 were agreed as an accurate record of the meeting.

- 7. Matters Arising
- a. Mrs Ward will speak to Mr Boorman at SDC regarding the laying of roadstone at E Ward Oxenhill Shaw.
- b. The Committee has been advised that the gate in the fence at Oxenhill Shaw (the south meadow) was installed by Mr Froud on behalf of SDC.
- 8. Allotments
- a. The Committee received the report from the OAA.
- b. There are three 5-rod allotments and one 10-rod allotment vacant.
- c. The new gate is proving very useful. The padlock was kindly donated by Otford Builders Merchants.
- d. Safe water tanks have been installed.

A number of older tanks have been retained. The Allotments Association will chase OAA the relevant allotment holders to new tank covers installed.

- e. Tap problems. One has been repaired. The second tap is being replaced following an unsuccessful repair.
- f. Trees are over-hanging certain allotments. These have been re-used as a cob-nut platt (approximately 2 allotments) and a wildlife area.
- g. Car Park. OAA is still discussing getting formal proposals and quotes. OAA
- h. Site Skip. The OAA has requested that the Parish Council orders a skip on a date to OAA/Office be advised.

The Allotment Association is holding an Open Day on 18th July, with allotment judging i. taking place on 15 July. Scarecrow judging will take place between 10am and 12pm on the 18th.

9. **OSA**

- 9.1. The following points were discussed:
- Cllr M Evans, Cllr J Edwards-Winser and Mrs K Drake met with the Football and a. Cricket Clubs to discuss cutting the pitches in the Recreation Ground. Cllr Edwards-Winser will discuss the proposal that the Parish Council contributes to grass cutting with the Council. It was agreed that the Football Club bills will be paid by the Parish Council and reimbursed by the Football Club.

The Committee considered that a request from OUJFC for permission from the Parish b. Council to place a container on the Recreation Ground for storage is not suitable for this area. There is an existing shed that could be upgraded with the ground being cleared, the shed being cleared out and new doors being hung. This would make the shed more secure.
